Background of Recommendation:

What is the need or problem, and how does it impact disparate populations?

Youth are sometimes in need of a safe place to deescalate while planning is finalized for their care. Rather than being placed in detention or long waits in an office setting, having an opportunity in a non-secure environment may meet their needs while allowing the probation officer or family case manager to complete and implement the plan for their care.

What data, research or other information did the recommender consult to formulate this proposal?

The group reviewed a program in Arizona that provides a facility for youth to deescalate while planning is finalized for their care. This need was additionally identified through the surveys that were sent to DCS and probation departments.

What disproportionality did the data reveal?

The data revealed that detention and/or the DCS local office is sometimes used on a short-term basis to be the location for the youth while the plan is created and implemented for the youth's care. There needs to be a system that can support the needs of youth in the appropriate level of care.

What is the current response to the problem by the State of Indiana?

Currently, detention or the DCS local office may be used on a short-term basis to be the location for the youth while the plan is created and implemented for the youth's care.

What solution is the recommender proposing, and how does it affect disparate populations?

The recommendation is to create awareness amongst shelter care facilities, probation departments and local DCS offices of the ability to use shelter care for youth that need that level of support for a short period of time while the youth's plan is created and implemented for their care. If implemented, this would allow for each youth to receive the care and support that met their individual needs.

How does the solution address the disproportionality in the data?

This solution addresses the disproportionality by allowing for each youth to receive the care and support that meets their individual needs.
