Summary of Recommendation:

The Youth Risk Behavior Survey is a component of the Youth Risk Behavior Surveillance System (YRBSS). YRBSS was developed by the Division of Adolescent and School Health (DASH), at the Centers for Disease Control and Prevention (CDC), in collaboration with more than 800 representatives from state and local agencies and other federal agencies. YRBSS was developed to monitor priority health-risk behaviors as well as obesity and asthma among youth and young adults.

Indiana obtained weighted YRBS data from 2003 to 2011 and in 2015. In 2017, the state did not have a response rate of 60% among the sampled schools and fell short of obtaining weighted data. The YRBS provides data to educators, mental health, medical, and other professionals who provide services to youth. In addition, this survey provides critical information necessary to support funding for youth programming. Currently, Indiana State Department of Health leadership is exploring various efforts to promote participation in the YRBS. In concert with those efforts, we are recommending a resolution of support and public promotion by the Commission on Improving the Status of Children in Indiana.

Background of Recommendation:

What is the need or problem?

In 2017, the state did not have a response rate of 60% among the sampled schools and fell short of obtaining weighted data. The YRBS provides data to educators, mental health, medical, and other professionals who provide services to

youth. In addition, this survey provides critical information necessary to support funding for youth programming. Without current data, supportive services, after-school programming, community based programming may not be meeting the current needs of the youth participants. YRBS data is used to support funding of programming and without the data, there could be areas that are not funded.

To ensure that Indiana obtains weighted data during the 2019 YRBS cycle, school participation among selected schools is critical. Currently, the Adolescent Health section of MCH is conducting outreach to administrators at sampled schools, and working with principals to begin scheduling dates for survey administration. There are some districts that historically decline survey participation, with support and public promotion from this commission, early outreach, and other efforts to connect with schools, we anticipate a successful 2019 YRBS cycle for the state of Indiana.

What is the current response to the problem by the State of Indiana?

Currently, Indiana State Department of Health leadership is exploring various efforts to promote participation in the YRBS. These efforts include a potential expansion of the YRBS, discussions about YRBS legislation, as well as outreach to increase awareness and obtain the support of administrators across the state of Indiana.

What is the recommender proposing, and how will it help solve the problem?

The proposal is that the commission will provide a letter of support or endorsement and promote survey participation among selected schools. Support from the Commission on Improving the Status of Children in Indiana will provide a clear connection to the data and may provide school administrators and other decision-makers who are not supportive of the survey to reconsider, increase their knowledge of the survey, and participate.

What data, research or other information did the recommender consult to formulate this proposal?

The CDC recommends Letters of Support as a means of gaining statewide participation and providing information about the use and value of this critical data. This proposal was developed using historical information about Indiana's challenges with obtaining weighted data due obstacles with gaining school participation.
