    - We are at a stand still without knowing what we have to work with for future plans.

- Barrett proposes that we have a fundraising event so that we can get some things going. Possibly through the golf course.
  - Barrett motions to sponsor a future fundraiser, Angie seconded, no objections, motion carries.

- Caretaker's were not in attendance, however it was discussed that things asked of us the last meeting were taken care of or in the process of being taken care of.
- Caretaker's health is waivering. Board notes that future plans for the position must be considered.

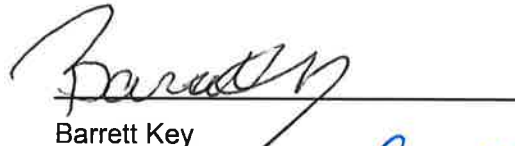

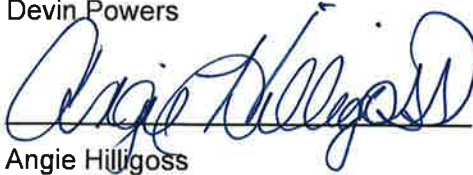

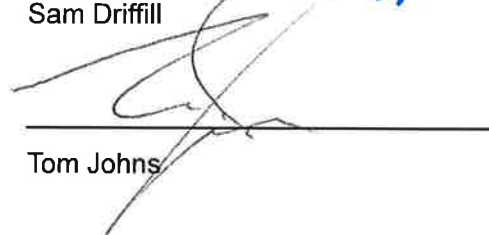
