

Alexandria City Council

Call to Order:

This meeting of the Alexandria City Council was called to order by Mayor Naselroad. Council Members - Roger Cuneo, present; John Burdsall, present; Wendi Goens, absent; Amy McCurry, present; Dave Luck, present; Donna Key-Kerr, present; and Jeremy VanErman, present. Also, in attendance were City Attorney, Sydney Darnall with Hayley Sears and Clerk-Treasurer Darcy VanErman.

Public Comment:

Lisa Summers, 114 S. Black St., addressed the Council to her concerns with the Board of Works approval of carpet for the Police Department with only two bids.

Approval of Minutes/Claims/Payroll:

Roger Cuneo motioned to approve the meeting Minutes from February 2, 2026. Jeremy VanErman second the motion. All in favor; motion carries.

Upon Mayor Naselroad introducing the Claims Docket, Amy McCurry inquired if the Department Head's had their annual budgets. Darcy VanErman stated not all had been disbursed. There was then great discussion amongst the Council regarding the Fund spending from the Fire Non-Revert Fund. After this discussion, Jeremy VanErman motioned to approve the Claims Report minus the Fire Non-Revert expenditures. This motion did not receive a second and died.

John Burdsall motioned to approve Warrant 19996 through 20080 in the amount of \$225,657.09 and to reassess the Fire Non-Revert Fund during the next meeting. Jeremy VanErman second the motion. Roger Cuneo, John Burdsall, Dave Luck and Jeremy VanErman were in favor; Amy McCurry and Donna Key Kerr opposed. Motion carries.

Upon introduction of the January 18, 2026 Payroll, Amy McCurry inquired of Darcy to the Appropriation lines utilized for the Payroll docket presented. Darcy asked her to meet with her after the meeting as it appears one of the forms Amy was using to compare was not the most recent form. Donna Key Kerr motioned to approve the Payroll from January 18, 2026 in the amount of \$167,961.24. Dave Luck second the motion. All in favor; motion carries.

Amy McCurry motioned to approve the January Pension in the amount of \$19,083.16. John Burdsall second the motion. All in favor; motion carries.

Communication:

Mayor Naselroad introduced Eric Freeman to the Council as the volunteer Park Superintendent for the next six months for the Park's Department. He also advised he reappointed Sam Driffell to the Park Board. Sam was unable to attend the meeting for introduction.

Jeremy VanErman inquired to the list of Council appointments. Mayor Naselroad advised they would be sent out to the Council.

Ordinances/Resolutions:

Ordinance 2026-001-C (Solid Waste), 2026-002-C (Sewage), 2026-003-C (Storm Water) and 2026-004-C (Water and Hydrant) were introduced to the Council for their review. The Public Hearing will be held on Tuesday, February 17, 2026 for possible adoption.

Old Business:

Mayor Naselroad allowed Sydney Darnall to assist the Council with walking through the format presented to them to begin considering the drafting of an Ordinance for the city to adopt proper Internal Controls to begin operating from. She asked for any questions of considerations to be emailed to the legal team for their review. Amy McCurry inquired to active inventory lists for each of the departments to which Sydney advised that will be worked through and formed in future actions after adoption.

New Business:**Other Business:**

Mayor Naselroad thanked the employees and departments for all of their hard work during our recent snow event.

John Burdsall wished both Amy McCurry and Donna Key Kerr a Happy Birthday and thanked the Council for all of their work within the community.
