Call to Order:

This meeting of the Alexandria City Council was called to order by Mayor Naselroad. Council Members - Roger Cuneo, present; John Burdsall, present; Wendi Goens, present; Amy McCurry, present; Dave Luck, present; Donna Key-Kerr, present; and Jeremy VanErman, present. Also, in attendance were City Attorney, Chou-il Lee and Clerk-Treasurer Darcy VanErman.

Public Comment:

Marisol Martinez, 933 W. Washington St., advised the Minutes were incorrect and she would bring those corrections to someone's attention.

Lisa Summers, 114 S. Black St., voiced her gratitude to the meeting venued back as well as her concerns to the roof of the Emery Lee Auditorium needing repairs, how to pay for it as well as legal fees being paid from Sewage and not the General Fund.

Approval of Minutes/Claims/Payroll:
