COMMON COUNCIL MEETING

APRIL 14, 2025

The meeting was called to order by Mayor Siepman with all council members present. The minutes were read and a motion to approve the minutes was made by Peggy Sluder with a second by Kent May, all in favor. A motion was made by Kelly Portteus and a second by Brad Duncan to approve the claims, all in favor.

Ordinance # 2025-2 was presented to the council, this ordinance is for excavation and construction within public rights-of-way, the motion to pass the ordinance was made by Peggy Sluder with a second by Brad Duncan, all in favor.

Graves pay application # 1 for the Water Treatment Plant in the amount of \$291,286.20 was presented for approval. The motion to pay application # 1 was made by Peggy Sluder with a second by Brad Duncan, all in favor. **Graves** pay application # 2 for the Water Treatment Plant in the amount of \$79,724.00 was presented for approval. The motion to pay application # 2 was made by Peggy Sluder and seconded by Kent May, all in favor.

Graves pay application # 15 A in the amount of \$289,184.14 for the Shakamak Sewer Project was presented for approval. The motion to pay the application was made by Peggy Sluder with a second by Kathy May, all in favor

Graves pay application # 15 B in the amount of \$82,459.27 for the Shakamak Sewer Project was presented for approval. The motion to pay the application was made by Peggy Sluder with a second by Kathy May, all in favor.

Old Business: Mayor Siepman announced that the Hanna Field Fund Raiser has raised \$27,000 so far with a match of \$10,000 total raised will be \$37,000. The first project for Hanna Field will be basketball courts and pickle ball courts.

The trash contract with Republic has been renewed as instructed by the council.

Police Chief VanHorn presented the JPD LIFESAVING AWARD to Skylar Scott for bravery and rescue of a drowning victim. Well done Officer Scott.

VanHorn also reported 205 incidents, some being 11 accidents, 9 residential alarms, 15 assists to the public, 55 traffic stops and issued 3 citations.

Chief VanHorn also asked for \$22,000 of LOIT money to be spent on the JPD roof. A motion was made by Peggy Sluder to replace the roof at the JPD and a lot \$22,000 from LOIT to pay for the roof. A second was made by Brad Duncan, all in favor.

Fire Department reported 32 runs, 11 being fire.

The Street Department reported working on the City Park Building, stating that they have about three days work left and the building will be completed. Landry reported she had ordered the tables and chairs for the building. The street department also put up street signs, repaired and opened up the bathrooms at the City Park and clean up brush and sticks at both City Park and Reservoir. Installed culverts and clean out ditches.
