Clerk-Treasurer Barb Hawn

- The General Obligation Bonds were sold on August 18, 2020. Banker's Bank was the winning bidder on the bonds with an interest rate of .65454%. This is much better than the projected rate and will save us around \$25,000 in interest.
- The Form 3 advertising the budget was published to Gateway on Tuesday morning. Public hearing is September 14 with adoption on October 12.
