**WWTP – New HOMA Pump Quote**

A quote for a new HOMA Pump was received from Indiana Pump. The cost of the pump is \$15,019.20 with an estimate for installation of \$1,890.00. Kenny Sprague of the Wastewater Treatment Plant recommended approval.

**Park Department – Woodlawn Park Tile Project**

With remaining funds from the sidewalk project at Woodlawn Park, Park Director John Parrish presented a quote from Gilbert Drainage & Excavating in the amount of \$7,234.50. This will eliminate the pooling of water in the park. He has a \$1700 cushion in the event there would be a sanitary line break.

**Building Administrator Elroy Mast**

- Family Express should be applying for their construction permit soon.
- The unsafe homes are moving along and getting ready to issue demo permits.

**Mayor Earle Franklin**


