1. Pro Tech Metal Finishing: Motion by Tom Janes and seconded by Earle Franklin that any back utility funds owed by Pro Tech as a result of a computer error on the part of the City should be forgiven. All ayes

2. Niblock Excavating – Invoice 31892 (Gerber/Richmond/Martin) Retainage. On motion by Tom Janes seconded by Mayor Fisel to release the retainage pursuant to Invoice 31892. Vote: all ayes
