A proposal from the Noble County Sheriff's Department for the city to have its own frequency on the dispatch system was received. The cost for equipment and installation is \$9500. The Sheriff's Department would pay \$3000, leaving a onetime cost to the city of \$6500 as the Sherriff's Department would pay for all maintenance. Funds are available in CCD to pay the city's share.

The quote is from 5 Alarm, the local distributer for the air packs. The total cost for the equipment is \$174,082. A financing option for 5 years with two annual payments of \$18,844.03, interest rate of 2.95%, was also received. Cum Fire funds would be used for the payments. City Attorney Hagen advised the board to take the quote under advisement to have the records reflect the statutory requirements regarding one quote.
