**Generator Service Agreement** 

Two proposals for generator preventative maintenance and repair were presented.

Reliable Generator & Electric LLC Proposal

\$2,305.00 for preventative maintenance. Don Ralph was present at the meeting. He started this business last year. He was a technician with Herrman & Goetz for six years. City Attorney Clouse confirmed he does not have a non-compete agreement.

Herrman & Goetz Inc. Proposal

\$3,145 for preventative maintenance. They are the installers of the generators in most of the facilities and have had the service contract for several years.

The board asked the department heads for input. All are currently happy with Herrman & Goetz and cautious about making a change currently. After the review by the city attorney, the document from Herrman & Goetz states automatic agreement renewal unless 30-day cancellation is received. However, the agreement did not indicate specific dates.
