#### WWTP - Sludge Press Proposal

Wastewater Superintendent Kenny Sprague brought a proposal from Prime Solutions for the purchase of a dewatering sludge press housed in a movable trailer which is a demo unit. They were at the plant last week to demo and he feels this is the best solution for the sludge press options. He prepared a costing sheet showing the savings the city could realize utilizing the press. The cost of the unit is \$149,990. Due to the elimination of items in the capital plan with the purchase of this trailer housed unit, the cost fits into the existing capital plan.
