Unfinished Business

1. Property at 600 South Martin Street

Citibank offered to donate this vacant lot to the city. Last year the city paid for the demolition and dumpsters of the burned out house totaling approximate \$5000. The taxes for 2013 of approximately \$526 would need to be paid by the city. Possible use would be a parking lot for Prentice Park which currently does not have parking. Council previously gave approval to pursue this donation.

2. City Employee Handbook

Council President Ken Schuman complimented those involved in the revision of the city employee handbook for taking on this insurmountable task. The final draft version protects both the city and the employees. The final handbook will be ready for council adoption at the April 23 meeting.

New Business

1. Waive Permit Fee – Citywide Garage Sale

Citywide garage sales are set for the second weekend of April and September. Historically council has waived the \$5.00 garage sale permit fee for the citywide sale.

2. Pay Increase for Board of Works

In November 2011, council voted to increase the council member pay from\$2500 to \$4000 annually in the elected official's salary ordinance. Members of the board of works are appointed and therefore salary is set in the city employee salary ordinance approved in August 2011. Mayor Fisel asked council to consider approving the same pay increase for Board of Works members, retroactive to January 1, 2012. This will affect two members as the mayor does not receive additional salary to sit on the board of works.

Street Superintendent Mike Burdette: The 2012 dead tree removal project is complete with 18 trees removed from the city right of way. Mike offered thanks to the water department personnel for their assistance.

Council Member Chris Fought: If possible, Chris would like to see a program put into place and in the budget to plant new trees after the tree removal.

Chris made a request on behalf of Operation Foundation. They are requesting permission to use the Farmer's Market Pavilion as their headquarters during the week of July 25 through August 1, 2012 as their headquarters.
