**Unfinished Business**

▪ **Department Heads Salary for 2015**

At the previous meeting, Mayor Fisel proposed the department heads for Street, Water, Wastewater, Fire, and Park move from an hourly basis to salary in 2015, with the recommendation the salary be set at \$48,000. The topic was opened for discussion.

Council President Ken Schuman researched department head salaries from the annual IACT wage survey and felt \$48,000 was mid-range of those compared. He noted the cooperation between departments. He believes salary is cost effective.

**Comments by Members of Council and Administration**

**Street Superintendent Mike Burdette**

- The new dump truck should be ready in about two to three weeks
- The stump grinder was rented during Operation Foundation and approximately 70 stumps were removed

**Park Director Alan Duncan**

- Thanks to Mike and the street department personnel for grinding the stumps in the park. Approximately 35 stumps were removed.
- Thanks to Bryan and the police department personnel for patrolling in the park – vandalism is down
- Thanks to the committee for bringing the car show to the committee for hosting Strawberry Days for bringing both events to Pettit Park

**Public Safety Director/Police Chief Bryan Shearer**

- Bryan addressed the pay for part-time police officers. The PT officers play an important role as they cover 32 hours per week. We are currently at \$13.92/hour for academy trained and \$11.25 for non-academy trained (1 year maximum). The area average for trained PT police officers is \$18.32/hour. Bryan would like to see an increase for 2015.
- The part-time firemen pay is currently \$12.25 for primary and \$10.20 for secondary. Firemen are not academy trained but are classified as Class I or Class II as well as first responders. Bryan would also like to see an increase for 2015. Historically PT police officers have been paid at a higher rate and he is not expecting the same rate.

- Bids/quotes will be taken for the 2014 paving program. Eleven streets will be done. The engineer's estimate is \$145,000.

- The May bank reconciliation and fund reports were sent to council members. This was confirmed by council member Chris Fought.

**Mayor Fisel's Comments**

- The county received a grant to replace the Pigeon Street Bridge. The anticipated completion is 2018. The public's safety is first and foremost. The garment building will be coming down and we have a developer interested in the site. The only other access is the brick street. We will make another attempt with the railroad to open the Pigeon Street crossing
