Unfinished Business

▪ **Part-time Police and Fire Wages**

Public Safety Director/Police Chief Bryan Shearer commented that he and Fire Chief Weaver are still working on the part-time wages for the fire department. He requested council members to take action only on the part-time police wages at this time.

The average wage for part-time police officers locally (Albion and Kendallville) is \$18.32. Shearer proposed an increase to \$16.50-\$17.00 per hour for academy trained part officers and asked that the increase take affect at the beginning of the next payroll as his budget has 79% of the year's total remaining. He also proposed that non-academy trained officers be paid \$13.00 per hour. Discussion led to the following:

New Business

▪ **Perry Township Fire Contract for 2015**

The 2014 agreement with Perry Township is \$28,053.41. Barb Donley, Perry Township Trustee, was present to ask that the board consider just a one percent (1%) increase for 2015. The township buys their trucks, pay for insurance, and gas. They like other entities have dealt with cuts due to tax caps. Perry Township receives from the City of Ligonier, one half of the Elkhart Township fire contract. For 2014 that amount is \$1709.28.

The growth index for 2015 is 2.7%. Further discussion led to the following:
