**Comments by Members of Council and Administration**

**Park Director Alan Duncan**

- A survey for the Parks and Rec was passed out Labor Day weekend and to the council and administration. A committee is putting a master plan together for grant applications.

**Street Superintendent Mike Burdette**

- Staff is getting equipment ready for fall and winter.
- Lincolnway Highway signs will be going up at the intersection of Cavin and Lincolnway west near Pettit Park.
- The citywide clean up is Saturday, September 17 from 8-1

**Public Safety Director/Police Chief Bryan Shearer**

- The county council unofficially voted to pass the Public Safety LOIT. This will mean approximately \$200,000 to Ligonier for Police and Fire. If passed by October 31, 2016, we will start receiving funds in 2017. The funds will be used to maintain what we have, not to add anything additional.
- Thanks to Eagle Ready Mix for their donation of the concrete barriers for the Marshmallow Festival.
- Expressed concerns about the safety issues on SR 5 due to the fact that the striping on the new road has not yet been done.

**Water Superintendent Jeff Boyle**

- Staff is busy installing new meters.
- The Flush Hydrants were ordered over a month ago and are still not in.
- Verizon is working at the tower. We are now receiving rent payments.

**WWTP Superintendent Don Skinner**

- The last major step of the project is close, but waiting on parts.

**Building/Zoning Administrator Earle Franklin**

- Received a state release for Structural Composite's building project.
- Working through some issues with NIPSCO on an abandoned line requiring a reconnect fee.

**City Engineer Rick Pharis**

- No quotes were received for the Amish horse shelter. We will formally set it for bid.
- The water grant is in process. Application deadline is in October with a December award.
- Three bids were received for the sea wall with the DR2 grant

A tentative award is pending funds to JCI Bridge Group.

- We are looking at applying for an INDOT Crossroads Community Grant which uses the special LOIT distribution for a 50-50 road improvement grant. The next grant round is expected to be announced in January.

**Council President Ken Schuman**

- Commented about how beautiful the flowers and the gardens are this year.

**Mayor Fisel's Comments**

- When the downtown apartment ordinance was drafted and passed, the plan commission recommendation of the apartment being in the rear of the building was inadvertently omitted. We will have Steve draft an amended ordinance.
