WNP Program

West Noble Primary School hosted the council in their school library. Members of the staff presented a program on the new Dual Language program, new this year. They currently have 46 kindergarten families (50% native English speaking and 50% native Spanish speaking) participating. Children are in an English speaking classroom 50% of the day and Spanish speaking classroom the other 50% of the day. These same children will follow through each year through sixth grade (they also hope to develop a high school program) with the goal of becoming bi-literate. Mrs. Riegsecker, the teacher for the Spanish speaking classroom demonstrated a teaching technique with members of council and the audience.

- The goal for the Story Walk was reached and the equipment has been ordered. Hope to have installed in May.

City Engineer Rick Pharis

- Three quotes for the sidewalk program were received and reviewed. The project will be awarded at the next Board of Works meeting. Young Services of Elkhart is the apparent low quote.
- The water project will bid late June/early July.
- A meeting was held with 10 building owners downtown regarding the river wall project. Thanks to Anna Fernandez for her assistance. The contractor is looking for equipment that will cause less vibration.
- Community Crossing grants for streets are under consideration in the legislature with a possible 80-20 match.

- Thanks to WNP for having us and for the program.
- Congrats to the police department for participating in a program at Richville Church.

- Inquired about the concrete light poles downtown. They are currently being manufactured in Texas but we do not currently have an arrival date according to Bryan Shearer who has been keeping in contact with AEP.
