Ordinance 961-2021 (Rezoning)

Rezoning of two parcels (57-01-34-400-011.000-014 and 57-01-34-400-010.000-014) from A-1 to PD-R, PD-B, PD-I was requested by the property owner. The Plan Commission sent a favorable recommendation to the Council for approval. Ordinance 961-2021 would rezone the property as stated. Mayor Fisel's Comments

Mayor Fisel updated council on some possible uses for the ARP Funds. She stated it is a once in a lifetime
opportunity to do some projects we have not been able to do before. Council will be responsible for adopting a
plan. We are expecting to receive a total of \$912,000. To date, the first installment has not been received.

- Possible projects: Extension of Pennington Way and a rail spur in the industrial park, Citywide WIFI hot spots, remodeling of the current fire station, utility projects, and Diamond Lake Road extension. She asked council to let her know of any project they might like to see the funding used for. Use of the federal funds has strict guidelines that must be met.
- We have been working with Baker Tilly to put a plan together and may be able to utilize other funding options as well including an EDA Grant for the industrial park project and SWIF grant for the utility projects.
