#### **Citizens Comments**

## Dan Stuckman of West Noble Waste Recovery LLC, Industrial Park - Pennington Way & Heckner Drive

Mr. Stuckman spoke about his new business, a waste transfer station, focusing recycling waste and pulling out valuable recycling. Because the community is so far from disposal sites he wanted to consolidate small loads from individuals, contracts, other haulers and be able to give the option to the community. His IDEM permit was secured. He has been using the facility for the past few weeks for training of employees. He hopes to open to the public in November. Homeowners can come in with loads by car, truck, trailer. Costs will be based on weight, seven cents per pound up to 1000 pounds, then 60.00 per ton. You will pay for only what you have with no minimum charge. Will take electronics and refrigerators with freon but no hazardous materials – no full paint cans – no asbestos. Appreciate the assistance of the city and city employees.
