#### **New Business**

#### Daric Weimer - Future Ligonier Alliance (Main Street Ligonier)

About a year and a half ago expressed interest in a community manager. Working with Lori Gagen of the Noble County EDC, she felt that instead of city providing this position, we should use the Future Ligonier Alliance (FLA), reform the 501C3 group, and have a position through FLA. As of two months ago, the FLA is in good standing with IRS and State of IN. They are moving forward to join Indiana Main Street with OCRA. The first step is a name change. Going forward the organization will be FLA DBA as Main Street Ligonier. They will be focusing on the area between Ligtel to the Liquor Store on Cavin Street and a few buildings on Main Street. The officers are as follows: Daric Weimer President, David Cisney VP, Chera Nelson Secretary, and Lori Cunningham Treasurer.

It is not the intent of Main Street Ligonier to step on city's toes but to be a support organization. A fundraising event will be held downtown in September with Food Trucks and live music. There are a few hurdles to overcome but they are working with Police Chief Bryan Shearer and Mayor Earle Franklin to run the event safely and within city guidelines.

Council Members thanked Daric and Mayor Earle Franklin stated it is good to see the community come together again with new faces and new ideas.

#### **Martin Street Manor Garage Sale**

The apartment complex wants to allow their residents to have a garage sale on the lawn next to the complex. The question of permit charge came up and the council was asked for their interpretation of the code. It was determined that a permit fee of \$5.00 for the complex should be assessed.

Chris Fought commented that The Plan Commission found that they would like to remove the garage sale verbiage from the zoning ordinance and let the council determine how garage sales should be handled. The Plan Commission will hold a public hearing at their next meeting regarding the zoning ordinance change.
