**Street Superintendent Mike Burdette**

- We are building a fence around the Recycle Center with fencing donated by WNSC.

- The project has not yet started but we are hopeful that it will start next week.

**Park Director John Parrish**

- We are doing prep work in the parks for the summer season.
- The concrete work in Woodlawn Park has started. The ADA ramp at the Woodlawn Park building and rail was completed today.
- The soccer season has started and the restrooms in Kenney Park are open. We will open the restrooms in the other parks this week.
- The restroom floors in Kenney Park will be coated so they are easier to keep clean.

- The fountain installation began today, and we anticipate it will take the week to complete. It will be a while before the water will be added as the sealant needs to be applied in warmer weather and will need to dry completely before water can be added.
