Received a letter from the Water Works regarding the lead and galvanized pipes and wondering what happens with the lead lines. Water Superintendent Jeff Boyle addressed the issue stating we were required to send the letters by IDEM to any resident who potentially may have galvanized or lead pipes in or leading to their home. He stated that unless the lead is cut, there is generally no danger since there is a coating inside the line. The Water Department personnel can come to the home and check for them. Concerning changing of lines, the rule reads we will provide a new line from the main to the curb stop but at this time the homeowner is responsible for the lines in their home.


