Balancing Correction  
The Lake City Bank reconciliation has been off by \$20.00 since November 2023 (the bank shows \$20.00 more than the city book). Clerk-Treasurer Barb Hawn has tried on multiple occasions to find the error, by verifying every deposit and every check in the book against the bank statement. She brought the error to the attention of the State Board of Accounts, who also went through reconciliation and was not able to find the error. She asked the council to approve an adjustment in the form of a \$20.00 receipt to the General Fund to bring the books back into balance.


- The staff made the final leaf pick up of the season today.


