Citizen Comments

Grace Caswell - Noble County Convention and Visitor's Bureau

Ms. Caswell provided an overview of Visit Noble County's 2025 community engagement efforts with the City of Ligonier. She highlighted their participation in the official opening of the 2025 season at the Ligonier Visitor's Center, the hosting of the May board meeting at the Center, and the installation of the *Destination Noble 2.0* banners throughout the downtown area.

She also noted the Ligonier recipients of Visit Noble County Tourism Grants — the Ligonier Marshmallow Festival and Stone's Trace Pioneer Festival — as well as continued collaboration with the Ligonier Chamber of Commerce. Additionally, she shared that Ligonier business *Grounded Coffee House* was added to the Indiana Foodways Alliance.

Ms. Caswell expressed enthusiasm for ongoing collaboration and plans to continue the partnership into 2026, including involvement with the *America 250* project. She commended Cyndi Schlemmer for her service representing Ligonier on the Visit Noble County Board as Board Secretary.

Comments by Members of Council and Administration

Public Safety Director/Police Chief Bryan Shearer

- The annual Bike Giveaway was held on October 15.

Clerk-Treasurer Barb Hawn

The transfer resolution that was tabled at the previous meeting has been withdrawn following receipt of an email from the SBOA Auditor. The email indicated contradictions between the information previously provided to the State Board of Accounts and the details published in the September 2025 SBOA Bulletin. According to the updated guidance, MVH Restricted Funds may be transferred to the Local Road and Bridge Matching Grant Fund.
