Comments by Members of Council and Administration

Public Safety Director/Police Chief Bryan Shearer

- Chief Shearer reported that one of the department's vehicles, a 2019 Dodge Charger, is experiencing steering issues that would require significant repair costs. He obtained a quote from John Jones for a replacement vehicle at a total cost of \$39,234.50, which includes a \$4,500 trade-in allowance for the current vehicle. He will be asking the Board of Works for approval on Wednesday.
- Chief Shearer reported that one of the City's police vehicles was involved in an accident on Saturday. The officer sustained only minor injuries. The insurance estimate has not yet been received; however, it is assumed that the vehicle will be considered a total loss.
- Chief Shearer also expressed appreciation to Keith Kizer of Foster's Garage for coming in on Sunday to perform an emergency hose repair on one of the department's pool vehicles.
