# **Comments by Members of Council and Administration**

## **Public Safety Director/Police Chief Bryan Shearer**

- Reported that the department received the replacement vehicle from John Jones.
- Stated he is working with Selective regarding the previously wrecked vehicle, which sustained over \$21,000 in damage.
- Noted he is coordinating with Landon at VS Engineering regarding the issue on SR 5 and additional related concerns.

# City Engineer John Nelson

- Provided an update on the CCMG Project: paving has been completed; approximately half of the driveways are finished, with hopes to complete the remaining work by tomorrow. The project deadline is December 22.
- Inquired about the Veteran's Memorial. Mayor Franklin stated we are tentatively planning underway for Memorial Day dedication.

# **Council Member Matt Kreager**

- Asked John Nelson about the status of signal poles; Nelson indicated it is doubtful they will be installed before the end of the year.
- Announced the kiosk for the Veteran's Memorial has arrived and installation is expected this week.

## **Council Member David Cisney**

Asked for an update on the city trash service for 2026. It was reported that the bid from Noble County Disposal was accepted, and the recycling proposal was rejected. The contract is on the Board of Works agenda for this Wednesday. The details for the changeover will be ironed out.

Shared information on the new software system that is available and rough estimates. A quote is in the works and will be brought to council in December for consideration.
