## **Equipment for Livestreaming/Recording Meetings**

After reviewing the equipment setup at WNSC, which was initially recommended by the Redevelopment Commission, it was determined that their system would not be suitable for the council room. WNSC's setup requires manual operation at each meeting and lacks automation.

Other systems used by the City of Kendallville and Noble County were reviewed. The River Systems setup was determined to be the best fit for the City of Ligonier. The company provided a one-time purchase option totaling \$13,136—\$4,252 less than the total cost of the monthly payment plan over three years (\$17,385). The one-time cost includes a three-year warranty, help desk support, and software updates.

The Board of Works has approved this purchase. Since the Redevelopment Commission had previously expressed willingness to fund the equipment, official approval was requested.
