Comments by Members of Council and Administration

Fire Chief Jeremy Weaver

- Kent Moser is retiring from the Volunteer Firefighters after 39 years of service. A celebration will be held at the fire station on Friday 8/26 from 6-8.

Street Superintendent Mike Burdette

- Niblock is working on the paving project. They ran into a problem on Wright Street, but the remainder is going well.

Public Safety Director/Police Chief Bryan Shearer

- The legislature is now allowing 24 years of longevity to be used in the computation of certified salary for the 1977 Police and Fire Funds. We are currently using 20 years and would like to see this changed to 24 years.

Motion to allow the change from 20 to 24 years for computation of certified salary: Ken Schuman

- Golf carts, ATV's, UTV's

We currently have a golf cart ordinance. UTV's on municipal streets has been up in the air for communities. Would like to create a UTV ordinance similar to the golf cart ordinance so that residents know what is allowed and they can get a permit like the golf carts.

- We also have a copy of old ordinance for ATV's which was overlooked with an update to the codification. We do not encourage to use on the streets – but would like to allow for residents to fuel up. We will proceed to have the ordinance added to the codification.

Water Superintendent Jeff Boyle

- Tower project is starting Tuesday of next week. Should take a month and a half. Verizon cell service is temporary moved to another tower. They will try to boost tomorrow.

WWTP Superintendent Kenny Sprague

- Vactor truck is down waiting on a transmission. Hope to have the part in this week and the truck back by next week.

Park Director Travis Brimhall

- Disc golf league started today, around 63 people participating.
- Flag football sign ups end Friday.

- Going to try to do a Track or Treat at Kenney Park on Trick or Treat night as an alternative for parents who do not want to take their kids on the streets. Will reach out to some businesses to see if they are interested in setting up. It will coincide with the city's Trick or Treat hours.

Council Member Chris Fought

- Inquired about the ARPA funds and what the budget plan is for the funds. We currently have two projects in this year. We did not put into next year's budget but will do additional appropriation if a project is moved into 2023.


Clerk-Treasurer Barb Hawn
