

ORDINANCE 2021 - 06

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF LOGANSPORT,
INDIANA FOR ADDITIONAL APPROPRIATIONS FOR THE CONTINUATION OF THE
50/50 SIDEWALK PROGRAM**

WHEREAS, The Common Council of the City of Logansport has established a 50/50 Sidewalk fund (#201-4-1020-442.032) and Curbs & Gutters fund (#201-4-1020-442.031); and

WHEREAS, the current (#201-4-1020-442.032) and (#201-4-1020-442.031) funds has been depleted; and

WHEREAS, the Common Council of the City of Logansport wishes for the continued replacement of sidewalks and curbs & gutters throughout the remainder of the year 2021; and

WHEREAS, the Common Council of the City of Logansport, Indiana believes an appropriation of money from the Motor Vehicle Highway (MVH) fund to be in the best interest of the health, safety, and welfare of the citizens of the City of Logansport, Indiana; and

**BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LOGANSPORT,
INDIANA:**

SECTION 1: That for the expense of said City of Logansport, Indiana, the following additional sum of money is hereby appropriated out of the fund named and for the purpose specified, subject to the laws governing the same:


SECTION 2: This ordinance shall be in effect after its passage by The Common Council of the City of Logansport, Indiana.
