

**ORDINANCE 2021 - 10**

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF LOGANSPORT,  
INDIANA APPROPRIATING MONIES FOR THE INSTALLATION OF A FITNESS  
COURT AT RIVERSIDE PARK**

**WHEREAS**, The Logansport Parks & Recreation Board approved Parks Board Resolution 2021-02 on March 5<sup>th</sup>, 2021; and

**WHEREAS**, Parks Board Resolution 2021-02 establishes a formal partnership with Logansport Memorial Hospital and Logansport Memorial Hospital Foundation and Logansport Parks Board; and

**WHEREAS**, LMH and LMHF have agreed to fund the installation of a National Fitness Court at Riverside park by providing \$50,000; and

**WHEREAS**, the payment of said funds will be provided as five \$10,000 payments provided on March 1<sup>st</sup> of the years 2021, 2022, 2023, 2024, and 2025 (Exhibit A); and

**WHEREAS**, the Logansport Parks Board approved Parks Board Resolution 2021-03 (Exhibit B) asking that the Common Council of the City of Logansport provide \$40,000.00 for the installation of the National Fitness Court; and

**WHEREAS**, the Logansport Parks Department agrees to reimbursed back to the CEDIT fund (#492) upon payment by LMH and LMHF the total amount of \$40,000.00; and

**WHEREAS**, the Common Council of the City Logansport, Indiana, approves \$40,000 from the CEDIT fund (#492) to the Logansport Parks Department for the installation of the National Fitness Court; and

**NOW THEREFORE, BE IT ORDAINED** by the Common Council of the City of Logansport, Indiana:

**SECTION 1.** The Common Council of the City of Logansport, Indiana approves \$40,000.00 from the CEDIT fund (#492) to be used by the Logansport Parks Department for the installation of the National Fitness Court at Riverside Park; and

**SECTION 2.** The monies available for the installation of the National Fitness Court will be placed in the Non-reverting Parks Capital Improvement fund (#477); and

**SECTION 3.** Upon the receipt of the \$10,000 payments from LMH and LMHF for the years 2022, 2023, 2024, and 2025, said funds will be transferred from fund #477 to the CEDIT fund #492; and

**SECITION 4.** This ordinance shall be in effect after its passage by the Common Council of the City of Logansport, Indiana.

**INTRODUCED, FILED AND APPROVED** by a vote of 6 in favor and 0 opposed on 5<sup>th</sup> day of April, 2021.

DULY PASSED, ORDAINED AND ADOPTED this 3<sup>rd</sup> day of May, 2021, by the Common Council of the City of Logansport, Cass County, Indiana by a vote of 6 in favor and 0 opposed.
