

ORDINANCE 2025-18

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF LOGANSPORT,
INDIANA, FOR ADDITIONAL APPROPRIATION OF AUCTION PROCEEDS TO
VARIOUS CITY DEPARTMENTS**

WHEREAS, the City of Logansport held a City Auction on June 7, 2025 for the sale of surplus items from various city departments; and

WHEREAS, the Common Council of the City of Logansport has recognized the disbursement of \$4,252.35 gained from the annual city auction into the NR Golf Operating Fund #481/5502; and

WHEREAS, the Common Council of the City of Logansport has recognized the disbursement of \$17,107.57 gained from the annual city auction into the MVH Fund #201/2201; and

WHEREAS, the Common Council of the City of Logansport wishes to allow the individual city departments to utilize proceeds from the items auctioned off from the inventory of their departments to help offset the unforeseen costs; and

WHEREAS, the Common Council desires to approve the additional appropriation of \$4,242.35 from the NR Golf Operating Fund #481/5502 and \$10,000 from the MVH Fund #201/2201.

NOW THEREFORE, BE IT ORDAINED by the Common Council of the City of Logansport, Indiana, that:

SECTION 1: That for the expense of said City of Logansport, Indiana, the following additional sums of money are hereby appropriated out of the fund name and for the purpose specified, subject to the laws governing the same:
