

**Parks Board Resolution 2025-13,**  
**A Resolution of the Logansport Parks and Recreation Board**  
**To Adopt a Part Time Sports Manager Position Page 1 of 2**

**WHEREAS,** The Logansport Parks & Recreation Board governs the facilities within the Logansport Parks Department as provided by the Logansport City Council Ordinance 2025-01; and

**WHEREAS,** The Logansport Parks & Recreation Department completed its 5-year Master Plan for the years 2024-2028 which included Parks and Recreation Needs Assessment Survey. The Finding Report (in Chapter 8 Appendix 216, Page 10 of Findings Report) states that the #1 unmet need is adult fitness and wellness programs by 2336 households.

**WHEREAS,** the “Top Priorities for Investment for Recreation Programs” based on the Priority Investment Rating results (Chapter 9 Appendix 264 page not listed) states in its graphs Adult Fitness & Wellness Programs being of high priority, as well as Youth Sports Programs & Camps being medium priority; and

**WHEREAS,** organized sports programs, leagues and athletic events have steadily increased in our parks by private citizens and small groups which require both dedicated oversight and coordination; and

**WHEREAS,** the Logansport Parks and Recreation Department recognizes the importance of fostering both youth, adult and senior developments, promoting healthy lifestyles and building community connections through accessible and well-managed sports and opportunities, as well as maintaining and continuing on with its well-established events, and programs with much more room to grow and improve upon for our community; and

**WHEREAS,** the Sports Manager position would allow the Logansport Parks and Recreation Department to strengthen its current program offerings, create many new opportunities for youth, families & seniors, and elevate Logansport Parks and Recreation as a hub for many recreation activities in Logansport and Cass County.

**WHEREAS,** the addition of a Sports Manager would provide leadership and accountability in the areas of:

- Sports development and expansion of youth, adult and senior leagues;
- Scheduling, communication and partnership with schools, clubs, and local organizations;
- Recruitment, training, and supervision of volunteers involved with Logansport Parks recreation sports programs;
- Ensuring facilities are effectivity utilized, maintained, and maximized for community and recreational use; and

- Enhancing overall quality, consistency, and safety of sports programming.

**NOW, THEREFORE BE IT RESOLVED** by The Logansport Parks & Recreation Board of the City of Logansport agrees to the following:

**SECTION 1:** That we formally support the creation and funding of a Sports Manager position within the Recreation Department, to better serve the athletic and recreational needs of our community.

**SECTION 2:** The attached job description-Exhibit A- shall be utilized for the person hired as Sports Manager as a guideline for establishment of wages, hiring a qualified person, their duties and responsibilities and to set goals for this position in the future.


**SECTION 3:** We request wages be included in the 2026 Parks General budget for one part time position to be hired with starting wages in the range of \$12-15 per hour, in the "Part-time Hourly" line item.
