

ORDINANCE NO. 2026- 101

**ORDINANCE APPROVING THE CARROLL COUNTY RECORDER'S
REQUEST TO USE THE COUNTY RECORDER'S PERPETUATION FUND
TO SUPPORT ALL OPERATING EXPENSES FOR THE 2025 CALENDAR YEAR**

WHEREAS, I.C. § 36-2-7-10.2 permits an Indiana County Recorder to pay for any portion of and/or all expenses of the County Recorder's Office from the County Recorder's Perpetuation Fund (the "Fund");

WHEREAS, the Carroll County Recorder (the "Recorder") has submitted a sworn statement relating to the Fund that the current revenue to the Fund is sufficient to fulfill the statutory purpose of the Fund; and

WHEREAS, the Recorder has submitted a sworn statement that the Fund has sufficient reserves consistent with the Recorder's plan to capitalize the next technology or other records management system upgrades necessary to fulfill the statutory purpose of the Fund and the Recorder has specifically requested that the Fund be used to pay expenses of the Recorder's office for the 2026 calendar year.

NOW THEREFORE, BE IT ORDAINED BY THE CARROLL COUNTY COUNCIL,
STATE OF INDIANA that:

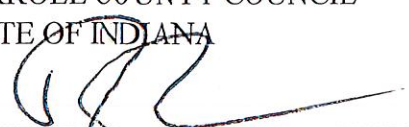

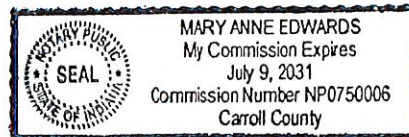
RECORDER'S SWORN STATEMENT RELATING TO PERPETUATION FUND
