The Cass County Council met at 9:00 a.m. in the Commissioner Hearing Room. Brian Reed opened the meeting with the Pledge of Allegiance and a moment of silence.

MINUTES

Brent Kelley made a motion to approve the minutes from the regular Council meeting as presented, George Stebbins seconded. The motion carried unanimously.

Grover Bishop made a motion to approve the minutes of the first reading of the 2012 budget, Ralph Anderson seconded. The motion carried unanimously.

ADDITIONAL

Coroner George Franklin appeared before the Council with a request for an additional \$12,000 for other supplies and autopsy. Ralph Anderson made a motion to approve the additional from the Host fund, George Stebbins seconded. The motion carried unanimously.


TRANSFER



The transfer will be from the group insurance account to other supplies in the amount of \$20,000 and to telephone in the amount of \$5,000. Grover Bishop made a motion to approve the transfer of funds, Ralph Anderson seconded. The motion carried unanimously.


PUBLIC COMMENTS & ADJOURN




There were no other public comments. Ralph Anderson made a motion to adjourn, George Stebbins seconded. The motion carried unanimously.



**Cass County Council
September 16, 2011
Second Reading 2012 Budget**

The Cass County Council met after their regular September 16th meeting. Present were Brian Reed, George Stebbins, Grover Bishop, Ralph Anderson, Jeff LeDonne, James David, Brent Kelley, Attorney John Hillis and Auditor Vaneen Ide.

The first item was the Park Department, the original Park Department budget was restored and the following cuts were made:

- 11026 Per Diem reduced from \$1350 to \$0
- 12005 Board Members reduced from \$2250 to \$0
- 15240 Unemployment reduced from \$7,800 to \$3,800
- 11521 Social Security reduced from \$ 15,589 to \$11,219
- 11522 PERF reduced from \$9,131 to \$7,360
- 15230 Group Insurance reduced from \$54,960 to \$41,220
- 32410 Printing reduced from \$1,700 to \$999
- 35120 Insurance reduced from \$25,000 to \$17,000
- 33251 Repair Building & Structure reduced from \$15,000 to \$8,600
- 35700 Dues/Subscriptions reduced from \$300 to \$0
- 18001 Part-time reduced from \$78,240 to \$43,240
- 17005 Security reduced from \$43,565 to \$21,445

Ralph Anderson made a motion to approve the reductions to Park Department budget as presented, George Stebbins seconded. The motion carried unanimously.

The Health Department, Health Maint., Public Health Coordinator and Tobacco Education original budgets were restored and the following changes were made:

Ralph Anderson made a motion to approve the changes to the budgets of Health, Health Maintenance, Public Health Coordinator and Tobacco Education, Grover Bishop seconded. The motion carried unanimously.

Ralph Anderson made a motion to reduce the levy for Health and Park and Recreation \$100,000 from each department and that sum to be applied to County General, George Stebbins seconded. The motion carried unanimously.

Superior Court II

Judge Richard Maughmer appeared before the Council and requested that his line item 47310 Superior Court Law books be restored to the requested amount. A contract is in place for the original amount budgeted. Ralph Anderson made a motion to restore 47310 from \$25,000 to \$27,000, Brent Kelley seconded. The motion carried unanimously.

Ralph Anderson made a motion to remove the Sheriff's line item 47245 Vehicles in the amount of \$25,000 from the Cumulative Capitol budget and move it to Public Safety budget, George Stebbins seconded. The motion carried unanimously.

Circuit Court

Judge Burns has requested a reduction in his Circuit Court staff. The position will be removed from the Circuit Court budget and placed in fund 234. The salary amount is \$22,578, social security is \$1,727.22 and the PERF amount is \$1,821. Ralph Anderson made a motion to approve as presented, Brent Kelley seconded. The motion carried unanimously.

Brian Reed reiterated seasonal and part-time salaries that passed on the first reading of the 2012 budget. Seasonal and interns will receive \$8.40 per hour. Regular part-time may receive \$8.40 and up to \$10.00 per hour at the officeholder/department heads discretion with the funds appropriated for 2012. Brian went on to state that additional appropriations for 2012 would be very limited and only approved in worst-case scenarios.

Ralph Anderson made an omnibus motion to approve all changes made to the 2012 budget today and at 1st reading, George Stebbins seconded. The motion carried unanimously.

BINDING BUDGETS

Ralph Anderson made a motion to table the approval of the binding budget for Fire District 1, Brent Kelley seconded. The motion carried unanimously. The Fire District 1 budget will be reviewed at the October meeting.

Ralph Anderson made a motion to approve the binding budget of Solid Waste as presented, George Stebbins seconded. The motion carried unanimously.

Ralph Anderson made a motion to approve the binding budget of the Airport Authority as presented, George Stebbins seconded. The motion carried unanimously.

Ralph Anderson made a motion to make the Walton Town Library a binding budget. Decreasing their county general from \$138,269 to \$131,273 and the lease remains the same, Jeff LeDonne seconded. The motion carried unanimously.


Ralph Anderson made a motion to make the Logansport Public Library a binding budget. Decreasing their county general from \$1,506,624 to \$1,432, 229, improvements to building remain as submitted, George Stebbins seconded. The motion carried unanimously.

NON-BINDING BUDGETS


Ralph Anderson made a motion to approve the remaining non-binding budgets as submitted to the Council, George Stebbins seconded. The motion carried unanimously.

PUBLIC COMMENTS & ADJOURN





Ralph Anderson





