


EXECUTIVE SESSION


CASS COUNTY COMMISSIONERS

**DISMISSAL OF PARK APPOINTED SUPERINTENDENT**

**APPOINTMENT OF NEW PARK SUPERINTENDENT**

Jim Sailors made a motion to appoint Lucas Beach to the position of Park Superintendent, Dave Arnold seconded. The motion carried unanimously. Lucas will begin his duties today at 12:00 p.m. July 20<sup>th</sup> on a volunteer basis. He will begin full time on July 23<sup>rd</sup> 2012.

**APPOINTMENT OF PARK LIAISON**

Dave Arnold made a motion to appoint Gene Powlen as liaison between the Park and the Commissioners, Jim Sailors seconded. The motion carried unanimously.
