The Cass County Commissioners met at 6:00 p.m. in the Commissioner Hearing Room. Present were Dave Arnold, Jim Sailors, Attorney Brad Rozzi and Auditor Vaneen Ide. WORK RELEASE



BUILDING SUPERVISOR



PUBLIC COMMENTS



Dave Arnold, President




Jim Sailors, Vice President
