

## **CASS COUNTY COMMISSIONERS**

**FEBRUARY 21, 2012**

The Cass County Commissioners met at 6:00p.m. in the Commissioner Hearing Room. Present were Dave Arnold, Jim Sailors, Gene Powlen, Attorney Brad Rozzi and Auditor Vaneen Ide. Dave Arnold opened the meeting with the Pledge of Allegiance.

### **AMEND AGENDA**

The following items were added to the agenda:

Building Commissioner

E-911-Personnel

Gene Powlen made a motion to amend the agenda, Jim Sailors seconded. The motion carried unanimously.

### **MINUTES**

Gene Powlen made a motion to approve the minutes as presented, Jim Sailors seconded. The motion carried unanimously.

### **CLAIMS & PAYROLL**

Jim Sailors made a motion to approve the claims and payroll as presented, Gene Powlen seconded. The motion carried unanimously.

### **COMMUNITY CORRECTIONS**

Dave Wegner appeared before the Commissioners with a request to replace 2 full time Correction Officers. There are three positions available, but Dave only wishes to replace two at this time. Dave also requested two part-time positions. Jim sailors made a motion to send a positive recommendation to the Cass County Council in regards to the open positions, Gene Powlen seconded. The motion carried unanimously.

### **SHERIFF**

Sheriff Randy Pryor appeared before the Commissioners with a request for time for an employee to use out of the sick bank. A meeting will be scheduled for this at a later date. There was also a request for FMLA. Jim Sailors made a motion to approve the FMLA, Gene Powlen seconded. The

motion carried unanimously. The Sheriff requested permission to hire a full time deputy. Gene Powlen made a motion to approve the hiring of a full time deputy, Jim Sailors seconded. The motion carried unanimously.

#### **E.M.A.**

Alvin Beckman appeared before the Commissioners with a request for approval of a grant. There were only two counties in Indiana that received this grant. Huntington and Cass counties. The grant is for \$200,000 and will be used for mobile data base. Jim Sailors made a motion to approve the grant, Gene Powlen seconded. The motion carried unanimously.

#### **COUNCIL ON AGING**

Beau Beard appeared before the Commissioners with information in regards to the Senior Citizen Center and Cass Area Transit. Mr. Beard informed the Commissioners that the Cass Area Transit had a successful compliance review with RLS and Associates. They had a recommendation to apply for possible grants to help replace aging vehicles. The report made recommendations to the Cass Area Transit to help them become compliant.

#### **INTERLOCAL**

Chris Gaumer and George Stebbins appeared and presented the revised interlocal agreement with the City of Logansport. This agreement would jointly fund a Building Commissioner and a secretary. Jim Sailors made a motion to approve the revised agreement, Gene Powlen seconded. The motion carried unanimously.

#### **E-911**


