The Cass County Commissioners met at 6:00 p.m. in the Commissioner Hearing Room. Present were Dave Arnold, Jim Sailors, Ralph Anderson, Attorney John Hillis and Auditor Vaneen Ide. Dave Arnold opened the meeting with an amendment to the agenda. The Airport Authority will be added between number V and VI. Jim Sailors made a motion to approve the amendment, Ralph Anderson seconded. The motion carried unanimously. Dave Arnold began the meeting with the Pledge of Allegiance, followed by a moment of silence.

#### **COMMUNITY CORRECTIONS**



#### **APPOINTMENT**


Jim Sailors made a motion to appoint Bob Vernon to the Health Department Board, Ralph Anderson seconded. The motion carried unanimously.
