

## CASS COUNTY COMMISSIONERS

JUNE 17, 2013

The Cass County Commissioners met at 6:00 p.m. in the Commissioner Hearing Room. Present were Dave Arnold, Jim Sailors, Ralph Anderson, Attorney John Hillis and Auditor Vaneen Ide. Jim Sailors made a motion to amend the current agenda, removing the Health Department, Ralph Anderson seconded. The motion carried unanimously. Dave Arnold opened the meeting with the Pledge of Allegiance, followed by a moment of silence.

### MINUTES

Ralph Anderson made a motion to approve the minutes as presented, Jim Sailors seconded. The motion carried unanimously.

### CLAIMS & PAYROLL

Jim Sailors made a motion to approve the claims and payroll as presented, Ralph Anderson seconded. The motion carried unanimously.

Sheriff Randy Pryor appeared before the Commissioners and presented his monthly report.

Sheriff Pryor informed the Commissioners that the increase in traffic arrests and citations was due to additional funding from the State for officers to conduct additional road blocks and check points for violations.

#### **MAINTENANCE DEPARTMENT**

Eli Smith appeared before the Commissioners with his report for May 15<sup>th</sup> through June 15<sup>th</sup>. Last Thursday night the Courthouse was struck by lightning which took out the chiller on the roof. The fan motor and control board for the pumps will have to be replaced. The week of June 22<sup>nd</sup> the maintenance staff is planning on doing some major electrical work at Community Corrections. This work will also affect E-911 so planning is very important. Preparations for restriping and labeling the annex parking lot are taking place. Earlier in the month a four drain line was replaced on the second floor jury room rest room. Some abandoned piping that was up in the ceiling was also removed.

#### **PARK DEPARTMENT**

Lucas Beach appeared before the Commissioners to request permission to fill a full time position at the park. Ralph Anderson made a motion to approve the filling of the full time position at the park, Jim Sailors seconded. The motion carried unanimously.

#### **BID 275 WEST PROJECT**

Jeff Smith appeared before the Commissioners with his recommendation for the 275 West project. Jeff recommended going with the lowest bid in the amount of \$721,528.83 received from E & B Paving, INC, located in Rochester. IN. Ralph Anderson made a motion to approve the bid from E & B Paving in the amount of \$721,528.83, Jim Sailors seconded. The motion carried unanimously.

#### Cass County Fire District Board

Bridget Enyeart submitted her resignation to the Commissioners. Ralph Anderson made a motion to accept the resignation of Bridget Enyeart, Jim Sailors seconded. All of the motions that were made were then voted upon and the vote carried unanimously.


#### **PUBLIC COMMENTS & ADJOURN**




Jim Sailors made a motion to adjourn, Ralph Anderson seconded. The motion carried unanimously.
