MAY 20, 2013

The Cass County Commissioners met at 6:00 p.m. in the Commissioner Hearing Room. Present were Dave Arnold, Jim Sailors, Ralph Anderson, Attorney John Hillis and Auditor Vaneen Ide. Dave Arnold opened the meeting by amending the agenda. Number 9 would be Highway Department – Bids & Geophysical. Number 10 would be the Health Department. Dave Arnold continued the meeting with the Pledge of Allegiance, followed by a moment of silence.

MINUTES

Ralph Anderson made a motion to approve the minutes as presented, Jim Sailors seconded. The motion carried unanimously.

Family Op has a new refrigerator and faucet in the kitchen.

E.M.A.

E.M.A. Director Alvin Beckman appeared before the Commissioners requesting permission to hire a new part time secretary. Dave Arnold reminded Alvin that part time cannot exceed 28 hours per week. Jim Sailors made a motion to approve the hiring of a part time secretary for E.M.A., Ralph Anderson seconded. The motion carried unanimously. Alvin informed the Commissioners that there was no Federal assistance offered to Indiana for the recent flooding. SBA loan approval was being offered for any flooding between April 17th and April 23rd.

CLEDO

Connie Neininger appeared before the Commissioners with her monthly report. Connie informed the Commissioners that the network breakfast held at IVY Tech had 5 companies attend. The core group that was formed to help guide Cass County will receive additional financial help from Purdue University for additional training. The team consists of Angie Berry, Kevin Bostic, Mark Hildebrandt, Joyce Mayhill, Connie Neininger, Tamara Ogle, Megan Paschen and Jim Schrader.

SRI

SRI requested that the tax sale support contract have an addendum added for an additional fee of \$5.00 due to a change in notification procedures for tax sale. They also had another addendum for the internet certificate sale service. Ralph Anderson made a motion to approve both addendums to the contracts, Jim Sailors seconded. The motion carried unanimously.

HIGHWAY

Jeff Smith appeared before the Commissioners to award the bid for work on EE-001 (Cliff Drive). Bids were opened at the May 6th Commissioners meeting. The work was awarded to Deichman Excavating. The amount of the bid was for \$184,900.00. Jim Sailors made a motion to award the bid to Deichman Excavating for \$184,900.00, Ralph Anderson seconded. The motion carried unanimously.

Jeff also presented to the Commissioners an agreement to do additional work by Geophysical. Line CM 150-13 starting at the White County, In. line on E 800 N. going east ending at 1050 W.
Line Cm-151-13 starting at the White County, IN line on W900 N going past N 525 W approx. 1 mile east
Line CM-152-13 starting at the White County, IN line on 1000N going east ending past CR 1000W approx. ¼ miles.

Jim Sailors made a motion to approve the work by Geophysical, Ralph Anderson seconded. The motion carried unanimously.

HEALTH DEPARTMENT

Lynda Kennedy appeared before the Commissioners requesting permission to replace a full time Environmentalist position at the Health Department. Ralph Anderson made a motion to approve the hiring of a full time Environmentalist for the Health Department, Jim Sailors seconded. The motion carried unanimously.

Ralph Anderson and Beth Myers made the presentation to the winners of the essay contest in honor of Logansport's 175th Anniversary. 
