

## **CASS COUNTY COMMISSIONERS**

**APRIL 15, 2013**

The Cass County Commissioners met at 6:00 p.m. in the Commissioner Hearing Room. Present were Dave Arnold, Jim Sailors, Ralph Anderson, Attorney John Hillis and Auditor Vaneen Ide. Dave Arnold opened the meeting with the Pledge of Allegiance, followed by a moment of silence.

### **MINUTES**

Ralph Anderson made a motion to approve the minutes as presented, Jim Sailors seconded. The motion carried unanimously.

### **CLAIMS & PAYROLL**

Jim Sailors made a motion to approve claims and payroll, except for check number 031911, Ralph Anderson seconded. The motion carried unanimously.

#### **PANHANDLE ORDINANCE**

John Bawcum, appeared before the Commissioners with an ordinance for the Panhandle Trail. The ordinance would allow law enforcement on the trail to enforce the rules. After some discussion there were two amendments to the ordinance. One to allow law enforcement vehicles on the trail and two, that leashes can only be extended to six feet while on the trail. Attorney John Hillis will make the amendments. Ralph Anderson made a motion to approve the Ordinance with the discussed amendments, Jim Sailors seconded. The motion carried unanimously.

#### **EMPLOYEE PICNIC**

Cindy Howard, secretary to the Commissioners, requested that the County Government Building be closed Wednesday June 26<sup>th</sup> from 11:00 a.m. until 1:00 p.m. for the employee picnic. This year's picnic will be held at France Park. Jim Sailors made a motion to approve the date and time of the employee picnic, Ralph Anderson seconded. The motion carried unanimously.

Connie Neiningner appeared before the Commissioners and presented her monthly report. Connie also included the financials for the first quarter of the year.


#### **PUBLIC COMMENTS & ADJOURN**
