

**CASS COUNTY COUNCIL  
JULY 19, 2013**

The Cass County Council met at 9:00 a.m. in the Commissioner Hearing Room. Present were George Stebbins, Stacey Donato, Brian Reed, Grover Bishop, Jeff LeDonne, James David, Attorney Brad Rozzi and Auditor Vaneen Ide. Absent were Brent Kelley and Attorney John Hillis. George Stebbins opened the meeting with the pledge of Allegiance, followed by a moment of silence.

**MINUTES**

Jeff LeDonne made a motion to approve the minutes as presented, Stacey Donato seconded. The motion carried 5 yeas, 0 nays. Brian Reed not present for this vote.

**SHERIFF**

Sheriff Randy Pryor appeared before the Council with a request to transfer monies out of series. The Sheriff requests that \$22,800 from account 13001 be transferred to account 47245 for the purchase of an additional vehicle. Jim David made a motion to approve the transfer of monies from account 13001 to account 47245 in the amount of \$22,800, Grover Bishop seconded. The motion carried unanimously. Sheriff Pryor introduced the Council to new deputy Brent McDonald.

**SUPERIOR COURT II**

Judge Rick Maughmer appeared before the Council with a request to transfer monies out of series. Judge Maughmer requests that \$7,500 from account 32633 to account 47240. Brian Reed made a motion to approve the transfer of \$7,500 from account 32633 to account 47240, Jeff LeDonne seconded. The motion carried unanimously.

**HEALTH DEPARTMENT**

Bob Vernon appeared before the Council and requested that the Health Department Administrator position be changed from part-time to full-time. The personnel committee recommended that this position be changed to full-time, with a salary of \$35,000. Monies for the increase must come out of the Health Department budget; there will be no additional appropriations. Jeff LeDonne made a motion to approve the change from a part-time position to a full-time position with a salary of \$35,000, Stacey Donato seconded. The motion passed unanimously.

There were no public comments. George Stebbins reminded the Council, budget workshop will be August 9<sup>th</sup> at 8:00 a.m. Brian Reed made a motion to adjourn, Grover Bishop seconded. The motion carried unanimously.
