4031 Quincy – McMahan

Mr. Koppe presented a picture that was taken in June, showing the progress: roof is demolished and cleared off, debris is cleaned and the house will be demolished but it has been a slow process.

Mr. Shaver explained that this Commission had motioned to have it secured up but now the owner has applied for a demolition permit for the structure.

Mrs. Clark asked if the doors and windows have been secured and Mr. Koppe stated yes.

Mrs. Shaver stated that there is no action needed at this time and staff will continue to monitor it.

Mr. Koppe stated that this property was on the tax sale but no one purchased it, it will now go to the Commissioners Sale. Mr. Koppe explained the 2 bids for demolition: Construction Unlimited, \$5,985 and from B&G Construction, \$5,500.

Mr. Sailors motioned to continue the order; re-inspect the property on October 26, 2016 and bring forward to the November 3rd meeting.

Mrs. Shaver stated that the case can be continued at the November 3rd meeting if necessary.

Mr. Stebbins seconded the motion and all were in favor.
