RESOLUTION TERMINATING THE AMENDED AND RESTATED DECLARATORY
RESOLUTION NO. 2013-04 AND RESOLUTION NO. 2013-05 RESOLUTION
CONFIRMING THE AMENDED AND RESTATED DECLARATORY RESOLUTION

WHEREAS, the County Council ("Council") of Cass County, Indiana ("County"), did on the 15th day of November, 2013, adopt a resolution designating certain real property ("Declaratory Resolution") located in the County and set forth in the Declaratory Resolution as an economic revitalization area under and pursuant to IC 6-1.1-12.1 ("ERA") and the Declaratory Resolution was confirmed on the 13th day of December, 2013, following a public hearing pursuant to IC 6-1.1-12.1-1 et seq. ("Act"); and

WHEREAS, the County Council ("Council") of Cass County, Indiana ("County"), did on the 15th day of December, 2013, adopt a resolution designating certain real property ("Declaratory Resolution") located in the County and set forth in the Declaratory Resolution as an economic revitalization area under and pursuant to IC 6-1.1-12.1 ("ERA") and the Declaratory Resolution was confirmed on the 13th day of December, 2013, following a public hearing pursuant to IC 6-1.1-12.1-1 et seq. ("Act"); and

WHEREAS, the County Council, ("Council") after careful thought and consideration, determines that the Amended and Restated Declaratory Resolution No. 2013-04 and Resolution 2013-05 Confirming the Amended and Restated Declaratory Resolution should be terminated.

WHEREAS, the County Council, ("Council") after careful consideration further believes that the Amended and Restated Declaratory Resolution No. 2013-04 and Resolution 2013-05 Confirming the Amended and Restated Declaratory Resolution shall terminate prospectively on June 30, 2026.

WHEREAS, the County Council, ("Council") further determines that the termination of Resolution No. 2013-04 and 2013-05 shall not impact or amend any prior Resolution or act of this Council granting tax abatements though the award of such tax abatements despite the fact that the abatement may occur subsequent to the termination of Resolution No. 2013-04 and 2013-05.

**NOW, THEREFORE, BE IT RESOLVED BY THE CASS COUNTY
COUNCIL OF CASS COUNTY, INDIANA, as follows:**

1. Resolution No. 2013-04, The Amended and Restated Declaratory

Resolution shall terminate prospectively on June 30, 2026.

2. Resolution No. 2013-05 Confirming the Amended and Restated Declaratory Resolution (Resolution 2013-04) shall terminate prospectively on June 30, 2026.

3. The County Council determines that the termination of the Resolutions (Resolution No. 2013-04 and 2013-05), shall not impact or amend any prior Resolution or act of this Council granting a tax abatement or tax abatements though the award of such a tax abatement or tax abatements may have been approved by an act or Resolution of the Council prior to the termination of the Resolutions (Resolution No. 2013-04 and 2013-05).
