

AN ORDINANCE OF THE CASS COUNTY COMMISSIONERS
AMENDING CHAPTER 2, ARTICLE 2, SECTION 61, OF THE CASS COUNTY CODE
BY THE AMENDMENT OF SECTION 61
ENTITLED: FEES FOR SERVICES FROM THE HEALTH DEPARTMENT

WHEREAS, the Cass County Health Department is now required to perform services and duties that were previously done by the State Department of Health, including but not limited to, administering immunizations; and

WHEREAS, the cost of vaccinations have increased.

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED, AS FOLLOWS:

Section I. Chapter 3, Article 2, Section 61, of the *Cass County Code* is hereby amended to read as follows:

Sec. 3-61 Fees for Services from the Health Department.

- (a) The Board of Health of Cass County shall charge a fee of Ten Dollars (\$10.00) for the issuance of a birth certificate; Ten Dollars (\$10.00) for the issuance of a death certificate and for the issuance of a wallet size, laminated birth certificate.
- (b) The Board of Health of Cass County shall charge a fee of Five Dollars (\$5.00) for each record search.
- (c) The Board of Health of Cass County shall charge a fee of Twenty Dollars (\$20.00) for each of the following:
 - (1) affidavit of legitimation
 - (2) paternity affidavit
 - (3) affidavit requesting amendment
- (d) The Board of Health of Cass County shall charge a fee of One Hundred Dollars (\$100.00) for the issuance of a Septic Permit.
- (e) The Board of Health of Cass County shall charge a fee of fifty dollars (\$50.00) for issuance of an Installer Certification. This fee must be submitted prior to the issuance or renewal of the certification.
- (f) The Board of Health of Cass County shall charge a fee of Twenty-five Dollars (\$25.00) for the issuance of an Annual Pool Permit, for public swimming pools only.
- (g) The Board of Health of Cass County shall charge a fee of one hundred dollars (\$100.00) for the issuance of an Annual Food Permit for "For Profit" establishments. Establishments that sell only prepackaged food and do not engage in food handling shall be charged Fifty Dollars (\$50.00) for the issuance of an Annual Food Permit.
- (h) The Board of Health of Cass County shall charge a fee of Twenty Dollars (\$20.00) per day, with a maximum charge of One hundred Dollars (\$100.00), for the issuance of a Temporary Food Permit.
- (i) The Board of Health of Cass County shall charge a fee of Fifty Dollars (\$50.00) for a Late Charge if the Annual Food Permit is not paid by January 31st.
- (j) The Board of Health of Cass County shall charge a fee of Five Dollars (\$5.00) for a TB (Tuberculosis) Test. There shall be no charge for tests related to contact investigations.
- (k) The Board of Health of Cass County shall charge a fee of Twenty Dollars (\$20.00) for a Flu Shot (Influenza).

- (l) The Board of Health of Cass County shall charge a fee for "Travel Immunizations" as follows:

(1.)	Hepatitis A	\$70.00
(2.)	Hepatitis B	\$60.00
(3.)	Meningitis	\$125.00
(4.)	Typhoid (boost q 2 years)	\$75.00
(5.)	Td (Tetanus/diphtheria) (over 18 yrs)	\$30.00
(6.)	IPV (Inactivate polio vaccine) (over 18 yrs)	\$35.00
(7.)		

- (m) The Board of Health of Cass County shall charge a fee of Two Hundred and Fifty Dollars (\$250.00) annually beginning January 1, of each year for a Tattoo Business Permit.
- (n) The Board of Health of Cass County shall charge a fee of Fifty Dollars (\$50.00) annually for a Tattoo Artist Permit.
- (o) The Board of Health of Cass County shall charge a fee for the following vaccinations, as indicated:


(1)	Chicken Pox (Varicella) (over 18 yrs)	\$120.00(children are free)
(2)	MMR (over 18 yrs)	\$70.00 (children are free)
(3)	Pneumonia (over 18 yrs)	\$75.00
(4)	Tdap (Adacel) (over 18 years)	\$45.00
(5)	HPV Vaccine (Gardasil)(over 18 years)	\$160.00
(6)	Shingles Vaccine (Zostavax)	\$190.00

- (p) The Board of Health of Cass County shall charge a fee of ten cents (\$.10) per page for copying documents kept by the Department.


Section II. All prior Ordinances or parts thereof inconsistent with any provisions of this Ordinance are hereby repealed.

Section III. This Ordinance is hereby passed and adopted at a regular meeting of the Cass County Commissioners of Cass County, Indiana, this 7 day of July, 2014.
