1. Call to Order

Chairman Andrew Steele called the meeting to order at approximately 4:45 PM.

2. Approval of Minutes

Minutes from the previous meeting were presented for approval.

Motion by Steele to approve the minutes.

3. Old Business

A. Campaign Finance Matters

Discussion was held regarding campaign finance reports and previously tabled matters.

Matt Czarnecki appeared before the Board regarding a delinquent filing. After discussion, the Board calculated the fine based on 22 days late at \$20 per day.

Motion by Steele to assess a fine of \$440 and allow payment at \$50 per month.

Second by Singleton.

Vote: Unanimous approval.

Dustin White appeared regarding a campaign finance matter.

Motion by Steele to assess a fine of \$150 due within 30 days.

Second by Singleton.

Vote: Unanimous approval.

The Board discussed payment methods and confirmed that personal checks are not accepted.

4. New Business

A. Proof of Publication

The Board acknowledged publication of required notices.

B. Campaign Finance Complaint Summary Update

Clerk Lynch provided an update and noted that a summary report is still in progress.

C. Resolution 2026-3 – Absentee Ballot Counting

Resolution establishing a 6:00 AM start time for absentee ballot counting on Election Day was presented.

Motion by Steele to adopt resolution.

Second by Singleton.

Vote: Unanimous approval.

D. Legal Notice for Primary Election

The Board discussed publication of the legal notice for the primary election.

Motion by Steele to proceed with publication.

Second by Singleton.

Vote: Unanimous approval.

E. Voting System Testing & Certification

The Board conducted testing of ballot cards and tabulating equipment and reviewed certification requirements.

Certification documents to be submitted following testing.

F. Mechanic Position Discussion

The Board discussed potential candidates for a Republican election mechanic position following a resignation.

Possible interviews and further review were discussed.

5. Public Comment

Members of the public commented on campaign finance enforcement and expressed support for increased accountability.

6. Adjournment

Motion to adjourn by Steele.

Second by Singleton.


Vote: Unanimous approval.

The next meeting is scheduled for Wednesday, April 29, 2026, at 4:45 PM.


