AGREEMENT


This AGREEMENT is between Scott McVoy, with a mailing address of 12524 Greenbrier Blvd., Sellersburg, Indiana (hereinafter referred to as "McVoy") and the Hoosiers for Jeffersonville PAC, with a mailing address of 46 Arctic Springs, Jeffersonville, Indiana (hereinafter referred to as "PAC"), collectively referred to as the "Parties," both of whom agree to the terms set forth herein.

McVoy agrees to serve as a consultant for the PAC whereby he shall be responsible for fundraising for the PAC including soliciting and collecting contributions. Additionally, McVoy shall assist/advise other political campaigns, on an as needed basis, in their fundraising efforts at the direction of the PAC. Specifically, McVoy shall coordinate the annual **I'm for Mike Moore Golf Scramble** including the scheduling of the event, soliciting and collecting contributions for the event, oversee and manage the activities on the day of the event.

In consideration of the aforementioned consulting services for the PAC, McVoy shall be entitled to a commission of equal to 10% of the net proceeds from the **I'm for Mike Moore Golf Scramble** to be paid by the PAC upon the collection of all contributions and payment of all event related expenses.


The term of the agreement shall be for one year commencing on June 1, 2023. This agreement shall automatically renew each year thereafter unless either party terminates.
