

Chief Deputy Auditor Phelps called to order the Crawford County Council Reorganization Meeting on 1/3/2025 at 4pm. Members present were Riddle, Scott, Breeding, Mason, Stroud, and Stevens. The absentee was Smith.

Opened the floor to nomination of president - Motion to nominate Chad Riddle made by Stroud. Seconded by Breeding. Motion approved with a vote of 5-0-1.

President Riddle – Opened the floor for nomination of Vice President. Motion to nominate Mark Stevens made by Mason, seconded by Breeding. Motion approved with a vote of 5-0-1.

Discussion about things that they will need to discuss at future meeting such as Attorney travel pay, Jacque Clements AIC contract.

Riddle stated he has a spot on the Economic Development Board being President. Redevelopment goes to Vice President. Conversation about switching boards and Shawn Scott possibly taking over one.

Discussion of keeping meetings the same and making adjustment during holidays.

Riddle recalled discussion with Scott and would like Auditor office to send out budgets to department heads and call for a mandatory meeting to discuss their budgets and raising any concerns or living within their budget.

Breeding asked Chief Deputy Phelps if there was anything sent for him for Indiana Region 15. Phelps mentioned the only thing the Commissioners mentioned was keeping the board the same. Discussion about being added to the Executive Board and if someone else would like to try and would be more effective than him. Breeding willing to switch with someone and then asked if Scott would like to take it.


Scott recommended that the Department heads be present at meetings to answer questions. Council agreed that they will have to set up boundaries.


Chief Deputy Auditor Phelps attached text message communication




