- III. Sheriff's Contract
 - a. Motion made by Magistrate Flanigan to approve changes to home detention contract with the right to rescind if IDOC does not approve the financial transfer. Motion second by Matthew Lorch. Motion passed unanimously.
- IV. Bylaws Amendment
 - a.
