i. Salary Increases and Teamster Contract

Stan Heil spoke on the negotiations for Teamster contract for the Road Department. The negotiations include a \$2,500.00 signing bonus. It is a 2-year contract for 2026 and 2027 with a \$3.70 increase per position. They agreed to four 10-hour days year-round. They are trying to coordinate a \$500.00 uniform allowance. The cost for 2025 is roughly \$90,000.00. He will request an additional appropriation out of the 1176 fund once negotiations are complete.

Mr. Heil said there are salary increases that need to be addressed.

- Nick Creevy has taken on full responsibilities as the Chief Operations Officer and is also involved as Planning Commission Director, Redevelopment Director and handling all the federal grants. The request is to move his salary from \$93,000.00 to \$102,300.00.
 Denise Konkle said she would like to wait until January for the new salary.
- Suzanna Worral has the support from the Commissioners for her salary to go from \$54,700.00 to \$60,242.00. She has taken on the duties and responsibilities for the Chase Building oversight. She coordinates all the administrative actions that are going on with all the facilities.
- Tom Hutchens and Robert Burk from the Road Department the Teamsters have agreed to relinquish a position to ensure their salaries stay higher than what is awarded by the Teamsters in this agreement. They eliminated a \$52,000.00/yr job, the savings back to the Council is \$19,623.96 in salary, \$4,287.00 in FICA and PERF and approximately \$18,400.00 in Health insurance savings. The total give-back to the County is approximately \$42,365.00
- Cindy Behr adjust her salary because of the additional duties and responsibilities of all the things hitting the Road Department in their operations.

Sam Sarkisian said he would like to see the job descriptions on Nick Creevy and Suzanna Worral.
